**NOTICE OF PUBLIC HEARING TO FURTHER IMPLEMENT THE
REQUIREMENTS OF SAN FRANCISCO PUBLIC WORKS CODE ARTICLE
25 BY ADOPTING OBJECTIVE STANDARDS FOR PERSONAL
WIRELESS SERVICE FACILITIES**

San Francisco Public Works will conduct a public hearing to further implement the requirements of Article 25 of the Public Works Code, as amended by Ordinance No. 190-19, by adopting Objective Standards to determine whether a proposed Personal Wireless Service Facility to be installed on a Utility (PG&E) Pole satisfies the applicable Tier A, B, or C Compatibility Standard. (*See* Public Works Code § 1501(b).) A copy of the proposed Objective Standards is attached

In accordance with Gov. Gavin Newsom’s statewide order for all residents to shelter in place – and the numerous local and state proclamations, orders and supplemental directions – aggressive directives have been issued to slow down and reduce the spread of the COVID-19 virus. Therefore, Public Works hearings that are held through videoconferencing will allow remote public comment.
